THE NPPF

- Para 214 and 215: Implementation
- Para 49: Presumption in favour of sustainable development; policies not up-to-date where no 5 years HLS;
- Para 47: 5% or 20% buffer;
- Para 14: Consideration of comparative merits, benefits and dis-benefits
- Para 7: Definition of sustainable development



ASSESSMENT OF CONFORMITY

- Does the plan positively seek opportunities to meet the development needs of the area?
- Does the plan meet the objectively assessed needs, with sufficient flexibility to adapt to rapid change?
- Do you have policies which reflect the principles of the presumption in favour of sustainable development?





- The size and relative scale and significance of the proposed development.
- The question of scale and significance is to be judged in the context of the individual planning authority, its housing requirement, strategy and local circumstances" (para 19)


